Legislation

Legislation by IFCA-JB;

The spring legislative session is in full swing. Currently the 102^{nd} General Assembly is in the midst of the Committee Hearing part of the session. The House continues to operate virtually, while the Senate is in session, however the hearings will be broadcast virtually as access to the Capitol is limited. We have identified 238 bills that may impact our members and, from this list, 90 that we are closely watching. You can see the list of the bills that we are watching on our website under the legislation watchlist. If you would like to read the synopsis on all 238 bills, it is located under the legislative additional resources link.

Some of the major issues we are working on include limiting restrictions on firefighting foam containing PFAS, changes to mental and behavioral transport, emergency response equipment for volunteer and POC Deputy and Assistant Fire Chiefs, stopping the legalization of fireworks and a number of labor related bills. While it is too early to know which direction any of these issues will go, we continue to make our position known. We will have a better idea as we approach the initial committee deadline later this month.
