

<u>IFCA Legislative Update</u> The legislative committee is hard at work watching the various bills that have been introduced in Springfield the past few weeks. The group will be evaluating the bills in the next week and determining the position of the Illinois Fire Chiefs Association.

This year we are taking a little bit of a different approach. You may recall that in past years, we would ask our members to "slip" many bills heading to committee. After working with our lobbyist and talking with some legislators, we have decided to slip many of the bills on behalf of the IFCA and not ask all our members to slip these bills. Typically, this will be done by President Christian. If you feel strongly on any particular bill, please remember that you can slip any bill on your own. Although we anticipate asking for your help less frequently this year, we will undoubtedly still be asking you to act when certain situations arise. Sometimes this will be slipping a bill, sometimes it might be contacting your Legislators directly (through email or by phone) and we might even ask our members to show up in Springfield for a hearing. Each situation is different, and we will be watching carefully to determine the best response.

The key to all this is, when we ask for your help, please take the time to help. We will try not to ask too often, but when we do, we need your help.

#### Tax Reform Act & Fire Sprinkler Incentives

In December, Congress passed the most sweeping tax reform legislation since 1986. Included in this legislation (P.L. 115-97) are two provisions that will greatly incentivize the installation of fire sprinklers. The National Fire Sprinkler Association appreciates the efforts and work that happened for 14+ years prior to this passage that allowed fire sprinklers to be included. A special thank you to Congressman Jim Langevin, who has championed this inclusion since the beginning as a result of

the Station Nightclub fire being in his district. We also thank all of our fire service partners — Congressional Fire Services Institute, International Fire Chiefs Association, International Fire Fighters Association, National Fallen Firefighters Foundation, National Fire Protection Association, Common Voices, National Volunteer Fire Council, Security Industry Association, Phoenix Society for Burn Survivors and many others. Understanding the costs of fire is important to business owners across America, and NFSA now shifts our work to sharing this information with our fire service allies and stakeholder groups that are directly affected.

## OSFM & IFSI News; Worth repeating

The Office of the State Fire Marshal and the Illinois Fire Service Institute have reached an agreement regarding testing for certification. Effective 01-Jauary-2018 and going forward, the OSFM has granted state equivalency to IFSI exams that lead to state certification. Consequently, IFSI courses/classes that lead to state certification will no longer require two exams. This process has been a long-anticipated venture that has finally arrived and will be very beneficial for firefighters across Illinois. Effective date forward is 01-January-2018.
