Kelvin Cohran A proud student of Caddo Parish Public Schools, he graduated from Woodlawn High School (1978); higher education includes: Wiley College (1999) Bachelor's Degree in Organizational Management; Louisiana Tech University (2004) Master's Degree in Industrial and Organizational Psychology; Ohio Christian University (2016) Honorary Doctorate in Christian Leadership; Creighton University (2018) Doctorate in

Interdisciplinary Leadership.

Cochran dedicated over 30 years of his life to fighting fires and protecting the communities in which he's lived and worked. He began his fire service career with the Shreveport Fire Department in 1981 as a firefighter, promoted to Fire Training Officer and served in this capacity from 1985 - 1990, promotion to Assistant Chief Training Officer, he was appointed Fire Chief of the Shreveport Fire Department on August 26, 1999. On January 2, 2008 he was appointed fire chief of the City of Atlanta Fire Rescue Department.

His exemplary service record drew the attention of President Obama who appointed Cochran as the administrator of the U.S. Fire Administration in 2009, the highest office in the profession. He then resumed his post as Atlanta Fire Chief in 2010.

After the city of Atlanta terminated Cochran's employment because of his Christian faith and beliefs, Alliance Defending Freedom (ADF) represented him in a federal lawsuit. A federal court ruled the city of Atlanta discriminated against Cochran's religious views and violated his First Amendment rights, and the city of Atlanta agreed to a favorable settlement.

He is married to Carolyn and the father of three children and has one granddaughter.



Dave McGlynn has been in fire and emergency Services since 2001, having served in both municipal and federal fire departments as a firefighter, driver/operator, company officer and training officer. He served as a captain at the U.S. Army War College for the Carlisle Barracks, PA, Fire Department and was recently the chief of the Training Division for the U.S. Military Academy West Point, NY, Fire Department. McGlynn is currently an assistant fire chief for

the Letterkenny, PA, Fire Department where he serves as the operations chief and training officer and is also a national public speaker and fire instructor, speaking on leadership development, training officer and program development, and motivational professional development. He holds an associate's of science in fire science, a bachelor's of science in fire & emergency services administration, and is currently pursuing his masters of arts in organizational leadership.

He is the first employee in the agency's history to have ascended to this position from the internal ranks and served under three governors.
