Tactical fitness training is not about working out for the sake of being good at working out, it is about developing your strength, your fitness, and your ability to react and perform in the real world. Dr. Matos will discuss utilizing food as medicine and adherence to the Mediterranean diet for the US career firefighter population. This has been proven to lower a firefighter's risks for diabetes, cardiovascular disease and cancer. The evidence comes from a Harvard study "Feeding America Bravest" which focused on adherence to the Mediterranean diet for firefighters in Boston and Indianapolis. The simplest change we can make for prevention of disease and promotion of long term health is to pay attention to the food we put in our bodies.

**David Martyn Conley** -For over twenty years, David Conley has been committed to the professional improvement of government and corporate employees, nationwide. Conley has facilitated and/or developed programs for organizations such as General Mills, and

Veterans Affairs. During that time, Conley has also designed and delivered programming for youth, that promote positive citizenship. A trained writer, actor and director, Conley develops "corporate theatre" programs that leave a lasting impression on participants. This impression makes it easier for participants to recall and apply the principles of any program.

Larry Conley is the Deputy Fire Chief of Training/Safety for the City of Collinsville, Illinois. He recently retired from the St. Louis Fire Department, where he served 30 years. He rose through the ranks and retired as a Fire Captain at one of the busiest firehouses in St. Louis. Larry received his bachelor's degree from Columbia Southern University. Conley is a national public speaker and, with his brother David, teaches a personal leadership workshop around the world. Larry and his brother have taught at the Fire Department Instructors Conference (FDIC) for over a decade and were the keynote speakers in 2021. Conley is a Fire Service Instructor II and evaluator, a recipent of the Excellence in Instruction Award from the International Society of Fire Service Instructors (ISFSI) in 2019. Larry was a nominee for the George D. Post Instructor of the Year Award in 2022. He hosts The Larry Conley Radio Show podcast on the Fire Engineering platform, serves on the FDIC education committee, and has authored articles for Fire Engineering magazine. For the past 22 years, Conley has volunteered at the Midwest Children's Burn Camp, serving burn-injured children, where he has been camp director for over 13 years. Larry is also a member of the Muddy River FOOLS and the International Society of Fire Service Instructors (ISFSI). Conley is currently pursuing a masters degree in Public Service Administration at Southern Illinois University-Carbondale.

For more than ten years, Conley, and his brother, Captain Larry Conley, have presented the personal leadership program, GLUE (Growing Leaders Using E.M.P.O.W.E.R.ment) to fire service professionals across the United States.



**Dr. Peter Matos is the Founder and Chief Medical Officer of Traekos Health, LLC.** Dr. Matos trained at John Hopkins, Walter Reed Army Medical Center, and Bethesda Naval Hospital. He has led and participated in major projects involving institutions such as Harvard University, Johns Hopkins University, the

Department of Defense, and Walter Reed Army Medical Center. Dr. Matos is an expert in Biologic surety and the management of select agent programs at federal facilities. He currently serves on the multiple company advisory groups as an SME in Chemical, Biological, Radiological, And Nuclear Defense, (CBRNE). Dr. Matos has experience working with the Armed Forces Health Surveillance Center (AFHSC), DTRA (Defense Threat Reduction Agency), DOD Global Emerging Infections Surveillance and Response System, and CDC. He has served as a public health emergency officer for 14 DoD installations and has participated in multiple disease and epidemiologic investigations. Dr. Matos has received extensive training in risk communication in a public health emergency and in exposure investigation.

During his residency training in Occupational Medicine at the Uniformed Services University of Health Sciences (USUHS), he completed a rotation at the International Association of Fire Fighters' (IAFF) Division of Occupational Health, Safety and Medicine. During this rotation, he became familiar with the occupational health concerns that firefighters face through review of reports, studies and medical standards maintained in the IAFF Health and Safety office. He became familiar with the IAFF/IAFC Joint Labor Management Wellness Fitness Initiative. NFPA 1582 and the IAFF Candidate Physical Abilities Test (CPAT). He conducted extensive literature searches to assist IAFF affiliates with issues related to firefighter health and provided assistance to local departments on topics including thyroid cancer, radiation treatment and assistance to IAFF Local 375 after a hazardous exposure fire. This training gives him a unique perspective and an excellent understanding of the health and wellness needs of firefighters.



### Ken Asta Kenneth Asta, CHC, CSCS, MBA - Rock Valley Health Director

Ken received his B.S. in Kinesiology from Northern Illinois University and Master's Degree in Business Administration from Western Illinois University. Ken is a Nationally Certified Health Coach with the American Council on Exercise and Certified

**Demond Dade -** Demond Dade served on Quincy Fire Department for over 21 years, with 11 years of experience as a Company Officer. Dade was promoted to Deputy Chief of Administration in January of 2020. In that role, he created Quincy Fire Department's COVID-19 policies and formed a Joint Task

Force to address Civil Unrest Response comprised of representatives from the Quincy Police Department, Adams County Ambulance Service, and the Adams County Emergency Management Agency, among others. He also took an aggressive approach to creating and implementing the department's annual training program; he created professional and career development plans, and in general helped to develop individual firefighters and increase their productivity. In March of 2021, Dade was hired by The City of Urbana Fire Department as the inaugural Deputy Chief of the department. In May of 2022, Chief Dade was named the Fire Chief of the Urbana Fire Department.

He served as President of MABAS Division 44, and is currently a member of the Governor's Fire Fighting Medal of Honor Committee. Dade is also a Field Staff Instructor for the Illinois Fire Service Institute at the University of Illinois, where he has promoted through the Instructor ranks in a short period of time due to his outstanding teaching skills, leadership, and dedication to the fire service. For a collective total of 23 years, he served as the Varsity Girls' Basketball Coach and as the Assistant Football Coach at Quincy Junior High and High Schools. Dade holds an Associate's degree in Applied Fire Science from John Woods College.



Joe Schrage began his fire service career in 1997 serving as a chaplain and a paid on call firefighter. He served the Illinois communities of O'Fallon, Mundelein, Swansea and West Frankfort before beginning his fulltime fire service career in the City of Highland Park. Joe has been with the City of Highland Park for 20 years serving in multiple roles and rapidly rising through the

ranks to become Fire Chief. **Shawn Sollberger** - Born and raised in the City of Peoria, Chief Sollberger is a third-generation firefighter in the City of Peoria. Grandfather William was an interim Fire Chief in the 1980s before he passed away due to lung cancer, and his father, Robert "Bob" retired as a Battalion Chief serving Peoria for over 33 years. Chief Sollberger graduated

from Peoria High School in 1992 and attended Illinois Central College playing baseball and attaining a Fire Science Degree and EMT-Basic certification along the way. He has received his Bachelor's degree in Fire Investigation and Fire Management from Columbia Southern University.

Chief Sollberger was hired by the City of Peoria April 3<sup>rd</sup>, 1998. Rising through the ranks and ultimately transitioning into management in December of 2019. He served shorts stints during the COVID19 global pandemic, as the Division Chief of Operations and the Assistant Chief, before ultimately filling the role of Fire Chief. Initially as an interim role starting February of 2022 until through an exhausting nationwide, Chief Sollberger was ultimately appointed full time in August 2022 by the City of Peoria.

Chief Sollberger served on the Union executive board for over 16 years, as a trustee and shift steward, and as part of the negotiations team for three consecutive contracts. He is now in his 4<sup>th</sup> contract cycle, lastly serving in the management role. Chief Sollberger has served as the labor chair for several committees, including Safety, SOG, Specialty Teams and the Foreign Fire Tax Fund. Additionally, he has served in the roles of Hazardous Materials Technician, Underwater Rescue Diver, Technical Rescue Certified in High Angle, Confined Space, and Trench, and as the city representative on the IL ETSB-9-1-1 board.
