**Position Summary:**

The School of Justice and Public Safety at Southern Illinois University Carbondale invites applications for one or more variable-time Assistant Lecturers to contribute to the school's graduate and undergraduate programs in Public Safety Management. This is a term, non-tenure track faculty appointment with an anticipated start date of appointment of August 16, 2021.

The Public Safety Management program dates to the late 1970s and provides higher education opportunities (B.S. and M.S. degrees) to individuals serving or seeking to work in public safety fields including fire, emergency medical, and emergency management organizations. The program is accredited by the International Fire Service Accreditation Congress (IFSAC) and the curriculum is Fire and Emergency Services Hire Education (FESHE) Initiative approved. Faculty hold advanced degrees and possess a wide range of field experience. Courses are taught online and at off-campus site locations in Joliet and Grayslake, IL.

**Duties and Responsibilities:**

Teach one or more graduate and/or undergraduate courses per semester as assigned in support of the Public Safety Management program. Faculty members will be expected to teach courses in a variety of formats including online and face-to-face (Joliet and Grayslake, IL) and on an accelerated and traditional schedule. Direct instruction may require evening and weekend assignments. Faculty will be required to hold office hours (remote as approved).

**Minimum Qualifications:**

- Master's degree in a public safety-related field
- Significant supervisory/administrative experience (3+ years) in a middle or upper-management position in a public safety agency (e.g., fire department, homeland security agency, police department, etc.) that includes documented evidence of career advancement and/or industry-related certifications.

**Preferred Qualifications:**

College/university-level teaching experience and/or industry training experience.
